Your blue roof will be installed FREE OF CHARGE.
This repair is temporary, so do not delay in contacting a professional about repairing your roof.

Please be advised of the following:

1. Have a photo ID, such as a driver's license, or proof of residency at the location.
2. Know the kind of roof you have. Structures with flat roofs, and tile roofs consisting of clay, slate or asbestos (transite) do not qualify. Mobile homes will be reviewed on a case-by-case basis.
3. The roof must have less than 50% structural damage to be eligible for the program.
4. The structure must be assessed as habitable before the blue roof is installed.
5. All debris must be removed before the roof can qualify.
6. Sign a Right-of-Entry Form

You will be required to sign a right of entry form to allow us to come onto your property to assess your structure and then assign your job to a contract roofing team.
